CLASP NOTES:

- ¹ This is the total number of children served with federal Title IV-E funds. It does not include those who are served solely with state, local or other federal funds.
- ² It is important to remember that “child placement and administrative” expenditures in Title IV-E are not just typical federal program administrative costs, such as eligibility determinations. They also include the very heart of child welfare – casework – including, but not limited to, assessments of children and families’ needs; identification and placement of a child in the most suitable foster, adoptive or kinship home; and development and refinement of the case plan, as well as presentation and review of this plan with court. Child placement and administrative expenditures do not include the costs of developing and running a statewide child welfare computer system, which is covered in the SACWIS column above.
