Several efforts have been under way at the federal level including legislative actions and Administration initiatives that impact disconnected and disadvantaged youth: My Brother's Keeper, the Interagency Forum on Disconnected Youth, Higher Education Reauthorization, and budget defense of non-defense discretionary programs.

10:00AM - 11:15AM Unpacking WIOA and its Implications for Low-Income and Disconnected Youth

The enactment of the Workforce Innovation and Opportunity Act (WIOA) marks a new era for state and local workforce delivery systems. Key changes—including targeting of formula funds to serve high needs youth and changes to youth eligibility requirements, among other things—mark new opportunities for investment in programming for older, disconnected youth. This two-part session will take a deep dive into the new law's provisions. The Department of Labor has much work ahead as it will publish its proposed rules for WIOA in January. We want to be an integral part in assuring that the spirit of the law is contained in the regulations, while at the same time pushing for priorities that may not have been explicitly stated in WIOA.

The discussion will also weave in themes from the morning conversation on WIOA, since that legislation strongly encourages a career pathway approach.

9:15AM - 10:00AM Educational Strategies for Over-age and Under-credited Youth

The phrase "over-age, under-credited" (OU) describes the academic background of a population of youth at the heart of our nation's dropout crisis. During this time, we will explore research from a new report documenting innovative, recuperative education strategies to assist youth who have not been successful in traditional school settings. Through contract and charter schools, parent engagement, competency-based learning, and blended and extended learning, OU youth are given the right environment and individualized attention to stay in school.

The goal of postsecondary education is to prepare youth and young adults for employment, but youth can never truly be ready without having actual work-related experiences. It will also explore the question: what does the WIOA law mean for building postsecondary pathways and employer relationships?
