


<sup>&</sup>lt;sup>4</sup>This is the total amount of state TANF MOE spent on child care and includes funds that may also have been counted towards CCDBG MOE. In 2006, CCDBG mandatory funding was increased by \$200 million. States were required to obligate, or legally commit, their share of these funds in 2006 but have until 2007 to spend them.
