

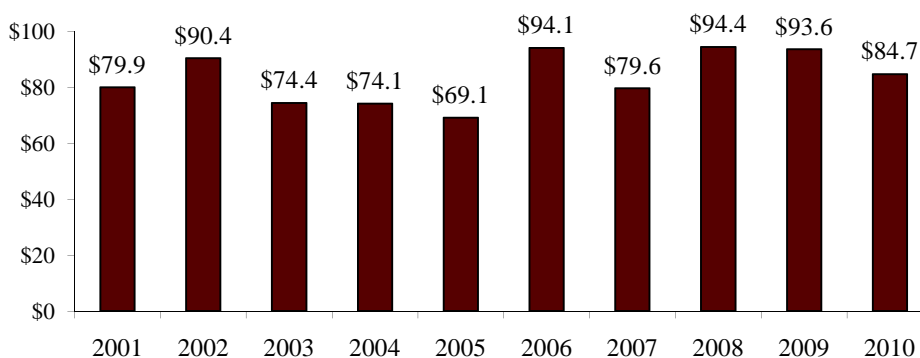

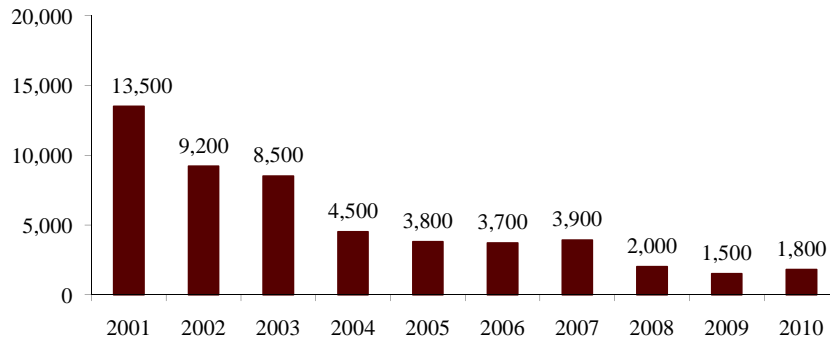

Average Monthly Number of Children Served in CCDBG in the District of Columbia

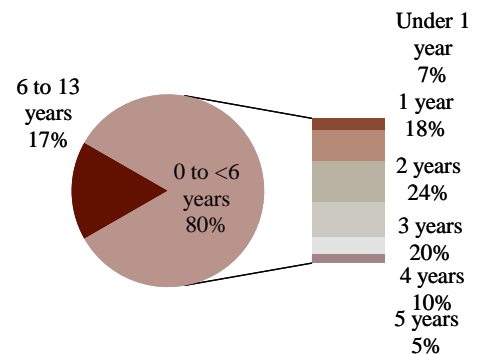

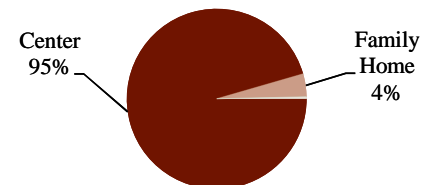
