

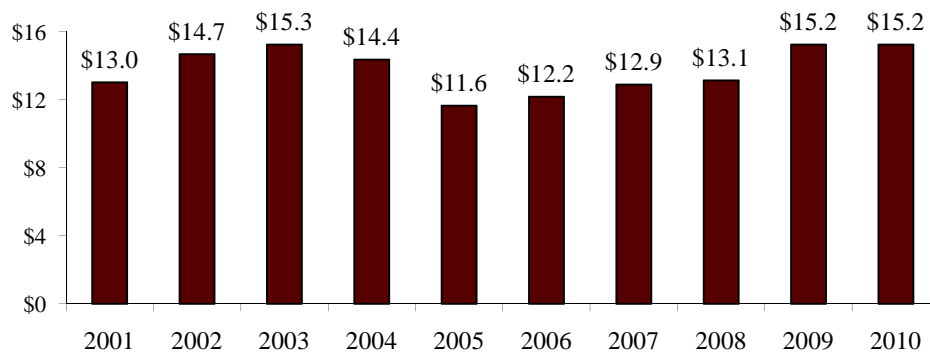

<sup>4</sup>This is the total amount of state TANF MOE spent on child care and includes funds that may also have been counted towards CCDBG MOE.

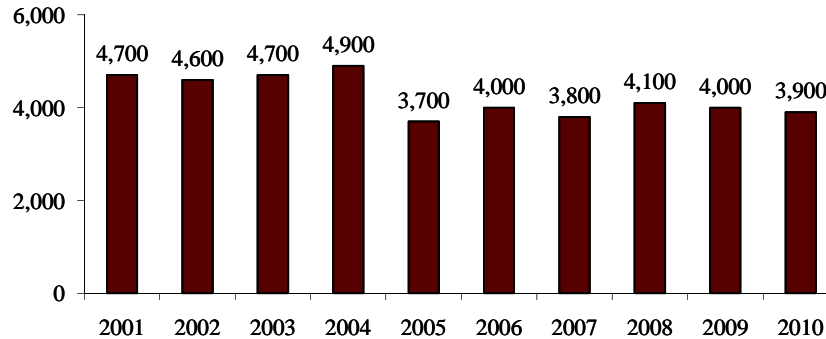

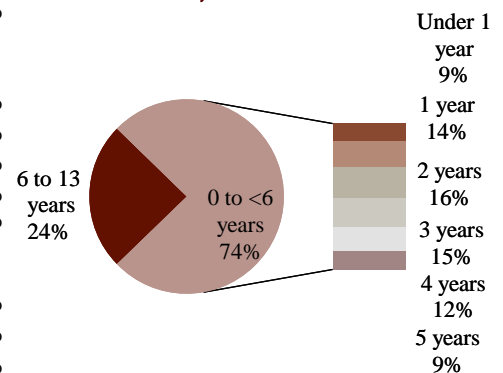

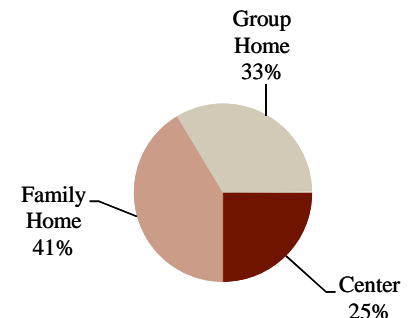
