

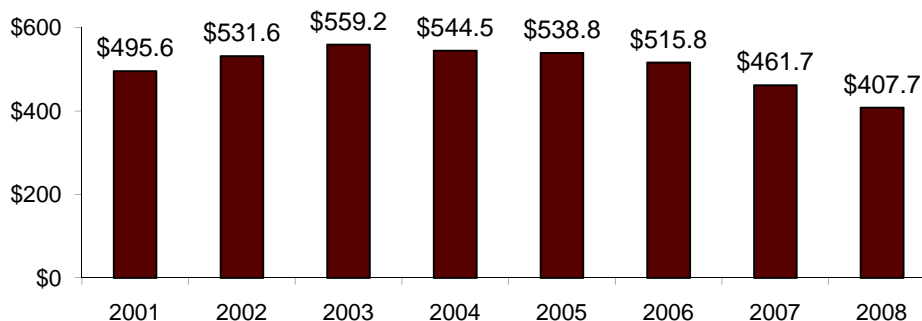

<sup>1</sup>To calculate total child care spending in a federal fiscal year, we sum state and federal CCDBG funds (including liquidated TANF transfers to CCDBG and CCDBG funds appropriated in prior years but liquidated in the given year); TANF funds spent directly on child care; and additional state TANF MOE.

<sup>3</sup>This is the total amount transferred to CCDBG in 2007 or 2008 regardless of whether it was liquidated in that year. TANF transfers that were liquidated in 2007 or 2008 are included above as CCDBG discretionary spending.

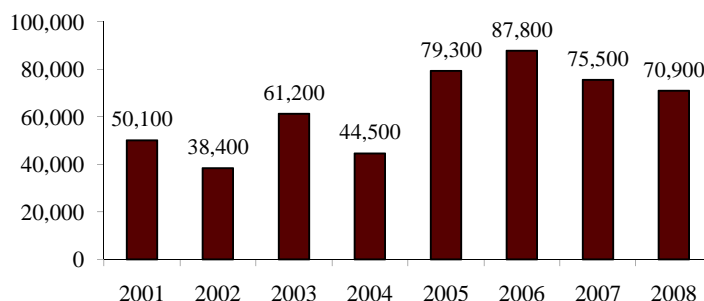
<sup>4</sup>This is the total amount of state TANF MOE spent on child care and includes funds that may also have been counted towards CCDBG MOE.

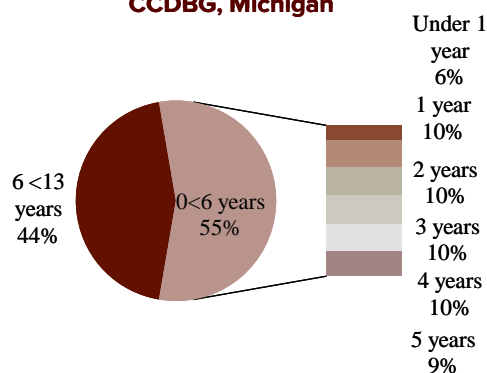

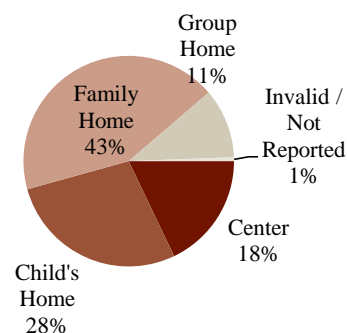
