## Youth Jobs Bills

- Opening Doors for Youth Act
  - \$1.5B in formula grants for subsidized summer jobs
  - \$2B in formula grants for partially subsidized yearround jobs
  - \$2B in competitive grants for community partnerships

### Employ Young Americans Now Act

 \$5.5 billion in immediate funding to employ 1 million young Americans in summer and year-round jobs

## Youth Jobs Bills

#### HERO for At-Risk Youth Act

- Encourage the business community to become a partner
- Provide a tax credit of up to \$2,400 for businesses that hire and train youth ages 16-25 who are out of school and out of work.

#### Creating Pathways for Youth Employment Act

- Local governments and community organizations apply directly for federal funding to create and expand summer and year-round employment programs for young people.
- Establish a five-year, \$1.5 billion competitive grant program for youth summer employment and a fiveyear
- \$2 billion competitive grant program for youth year-round employment that will provide financial support for communities seeking to create, improve, or grow summer and yearround employment opportunities for youth ages 14-24

## **Higher Education**

- Reauthorization unlikely this year or even next year
- Year-round Pell was included in appropriations process
- There is still Ability To Benefit Provision for Students in Career Pathways
- Access issues related to justice-involved individuals
- SUCCESS Act (HR 1432) gives Pell eligibility for students with drug convictions -- bipartisan
- REAL Act (HR 254) reinstates Pell for individuals incarcerated in a federal or state penal institution, seeking republican sponsors

## Juvenile Justice and Delinquency Prevention Act

- JJDPA is the only federal statute that sets out national standards for the custody and care of youth in the juvenile justice system
- Four core mandates (protections)
  - Prohibits detaining status offenders
  - Adult jail removal
  - Sight & sound separation
  - Reduce racial and ethnic disparities
- Passed Senate and House; Senate Majority Leader has yet to appoint conferees, and refuses to bring bill to the floor
  - Deinstitutionalization of Status Offenders (DSO) provision will be a sticking point in negotiations

### Perkins Career & Technical Education

- House passed a reauthorization bill in June
  - Bill took away secretary's authority on enforcement and maintenance of effort
- Senate members are urging for its passage
  - A letter sponsored by Senators Jim Inhofe (R-OK) and Claire McCaskill (D-MO), encouraged the HELP committee to take up Perkins reauthorization
