

Welfare Caseloads Increase in 27 States Between June and September 2003

National Welfare Caseload Remains Flat; Contrasts with Rising Food Stamp Caseload

The Center for Law and Social Policy (CLASP) has collected new data on Temporary Assistance for Needy Families (TANF) caseloads through September 2003 for 50 states and the District of Columbia. These are the most current and complete data available. 2

Between June 2003 and September 2003, 27 states reported caseload increases and 24 reported decreases. The changes in most states were small; for 34 states, the September 2003 caseload was within 3 percent of the June caseload. Overall, the national caseload remained essentially flat, declining by 0.1 percent. The national caseload was 2,021,089 families in September, with 2,762 fewer families receiving assistance than in June.

Caseloads increased slightly over the past year but have fallen since March 2001, the official beginning of the 2001-2002 recession. Between September 2002 and September 2003, the overall caseload increased by 0.4 percent and 30 states had caseload increases. Most states (28) have experienced a caseload increase since the start of the recession in March 2001; however, the overall caseload decreased by 3.7 percent since that time.

Over the past two years, there has been a sharp contrast in changes in participation between TANF and the Food Stamp Program. Between September 2001 and September 2002, food stamp receipt went up by 10.6 percent, while TANF caseloads fell by 3.4 percent.³ Between September 2002 and September 2003, the number of households receiving food stamps increased


¹ CLASP has been gathering caseload data with the cooperation of state TANF agencies (for simplicity's sake, we refer to the District of Columbia as a state in the rest of our analysis). These data do not include caseload information for Puerto Rico, Guam, or the Virgin Islands.


² State TANF caseloads generally count only those recipients receiving cash assistance, not other TANF-funded services. CLASP has posted these figures in an effort to supplement data available from the U.S. Department of Health and Human Services (DHHS). 14.8 percent, while the TANF caseload increased 0.4 percent. Between September 2001 and September 2003, the number of households participating in the Food Stamp Program increased by 2,064,112, while the number of families receiving TANF *fell* by 62,239. Although it might be expected that caseloads for the two programs would move in tandem during an economic downturn, it appears that the Food Stamp Program has been far more responsive to increased economic need than has the TANF program.

Additional Findings

In reviewing the new caseload data, CLASP also finds:

- From June to September 2003, 24 states reported caseload decreases. From June to September 2003, 27 states reported caseload increases, while 24 reported decreases. The magnitude of the average increase was smaller than the average decrease, causing the caseload to remain relatively flat. The average increase was 1 percent compared to the average decrease of 4.2 percent. Over the same period last year (June 2002 to September 2002), 31 states experienced caseload increases.
- Over the year, from September 2002 to September 2003, TANF caseloads increased in 30 states. The average increase over this period was 6.0 percent. In comparison, during the prior year, from September 2001 to September 2002, 24 states reported increases, averaging 8.7 percent.
- Two states experienced caseload growth of at least 15 percent in the past year. Idaho's caseload grew by 22 percent and Arizona's by 17 percent between September 2002 and September 2003.

- Three states experienced caseload declines of at least 15 percent in the past year. Between September 2002 and September 2003, Illinois and Nevada reported a caseload decline of 18 percent each, while Utah's caseload fell 24 percent.
- Most states are experiencing relatively small caseload changes each quarter. In the most recent quarter, between June 2003 and September 2003, 34 states saw their caseloads change by less than 3 percent. Eight states (Alaska, Missouri, Montana, Nevada, New Mexico, Texas, Utah, and Virginia) saw their caseloads change by more than 5 percent. The remaining 9 states fluctuated between 3 and 5 percent.
- Between the "official" start of the recession in March 2001 and September 2003, 28 states have experienced a caseload increase. On average, these states have seen their caseloads increase 16.2 percent during this time period. The states experiencing the largest increases over this period are Arizona (56.0 percent), Idaho (33.1 percent), Colorado (32.9 percent), Nevada (32.0 percent), and Mississippi (29.6 percent). For the 23 states experiencing caseload declines during the recession, the average decrease has been 13.5 percent, with the largest declines in Illinois (45.5 percent), New York (36.0 percent), Wyoming (31.7 percent), and Hawaii (27.4 percent). The overall caseload decreased 3.7 percent overall since the recession began.
