CLASP's <u>DataFinder</u> is a custom, easy-to-use tool developed to provide select demographic information as well as administrative data on programs that affect low-income people and families. Users can create and download custom tables that present a national picture, a state picture, or a comparative look at states and communities. State data are available on Head Start participation, child care spending and participation, TANF expenditures, young child demographics, and poverty.
