25 Years Child Care & Early Education



CLASP celebrated 25 years of leadership in the child care and early education policy space, ensuring families with low incomes have access to quality care and supporting families' economic security and well-being. The Child Care and Early Education team has driven historic policy wins, from securing \$50 billion in relief during economic crises to supporting improvements in child care access to advancing racial equity.

CLASP Fights for Paid Leave



In June, CLASP and Family Values @ Work convened with over 100 paid leave advocates, state administrators, and policymakers from 18 states and D.C. for the **Paid Family and**Medical Leave Collaborators Convening. This gathering strengthened cross-state collaboration, reinforcing the momentum toward equitable, comprehensive paid leave for all.



2024 Highlights

Cross-Team Collaboration

In July 2024, CLASP released "A Path Forward," a series examining the progress we've made in key policy areas in addition to the work that remains. The series offers a roadmap to continue the essential work that will ensure all families receive the access, support, and care they need and deserve, while laying out what is at stake if we lose ground on the progress already made.



published the brief "The Child Tax Credit: What's at Stake?" showing how expanding the Child Tax Credit (CTC), as part of the 2021 American Rescue Plan Act, shrank child poverty rates among Black and Hispanic/Latino children by 8.8 and 6.3 percentage points, respectively, from 2020 to 2021. Yet ending the fully refundable CTC at the end of 2021 caused a sharp rise in child poverty with more than 5 million children pushed back into poverty.

Supporting Mental Wellness in Immigrant Communities


NATIONAL IMMIGRANT INCLUSION CONFERENCE

Isha Weerasinghe, Associate Director for Mental Health and Well-being, moderated a panel at the 2024 National Immigrant Inclusion Conference, focusing on immigrant mental health. We strengthened our partnerships and brought more focus to the intersection between immigration and mental health.



BROKEN HOPE

In December 2023, Suma Setty and the Ohio Immigrant Alliance (OHIA) partnered to release the book Broken Hope: Deportation's Harms and The Road Home. This book and subsequent issue brief compiled stories from over 250 people who were deported, the majority of whom are of African origin. The book and brief highlight the crushing consequences of deportation and the connection between immigrant mental health and the current U.S. immigration system. In 2024, CLASP and OHIA organized a Hill Day, supporting people directly harmed



by our racist and unjust immigration system to distribute Broken Hope and speak directly to policymakers about their experiences.


CLASP's Youth Work Takes Off!
